At the end of the 80s of the last century a group of experts - people from the system of the USSR State Committee for Inventions and Discoveries created the first non-governmental agency of intellectual property INTELS. After registration as a legal entity on 21st of September, 1988, INTELS specialized in a wide range of services. 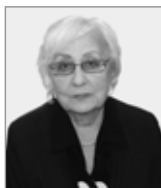

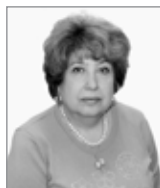

## Services against counterfeit and gray imports

- Preparing and filing an application for inclusion of a trademark or any IP object into the Customs Register of Intellectual Property Objects (CRIPO)
- Preparing and filing an application for renewal of IP object registration in the CRIPO
- Preparing and submitting complaints on the illegal use of IP rights to the customs authorities and police departments with the express goal of bringing the alleged infringers before the competent courts
- Preparing and submitting statements of claim to courts in order to recover damages and receive monetary compensations for IP infringement
- Representation in administrative authorities and courts
- Conducting counterfeit analysis of goods
- Conducting investigations to obtain evidence of infringement
- Preparing and submitting of warning letters to infringers
